Trapped and Blocked

Have you looked at your emergency exits or stairwells lately? Are there boxes or discarded furniture blocking them, or other items waiting to be moved?

If this is the case, then you have the makings of a tragedy if your building needs to be evacuated.

One thing often seen during a safety inspection is blocking violations. What types of things should not be blocked? Below is a partial list of common items found in most workplaces. However, there can certainly be others:

- Emergency exits
- Eyewash stations and showers
- Electrical panels
- Electrical disconnects
- Fire extinguishers
- Pedestrians aisles
- Stairwells

How serious is this issue? Locked and blocked exits were factors in the deaths of 25 and injury of 53 in a 1991 North Carolina fire that resulted in the owner of the company going to prison.

The good news is that blocking is easy to identify and fix. Consider painting zones around these areas and installing signs to inform people they can't be blocked. Regular inspections, good housekeeping, and emphasis on keeping these areas cleared is the most important element in preventing such issues. Specifically look for items that "have always been there" as these permanently blocked items need to be addressed.

Take a look around your work area today when you head out. See if there is clear access to the electrical panels and fire extinguishers. Let a supervisor or your safety coordinator know if something is blocking access. If it's your area, what can you do now to ensure the area is clear? Look to see if any items have been "permanently" blocked by design.

It is certainly better to clear these areas now than risk not being able to evacuate later. You might also want to consider doing some evacuation and accountability drills to make sure people know where to go and what to do afterwords.
