My Car Does What?

Fleet and Car Safety Features

Nearly every car on the road today has safety features that can help drivers be safer. You may already know some of these, and some you may not even realize your car has!

There are some great online sites that help you understand what these features do. Many of these new safety features are not yet standardized. Your car's features may be different than someone else's. Be sure to check your owner's manual to best understand how your car works.

If you're responsible for your local government fleet operations, you might want to consider adding some training on what these features do, and how they function. For example some features (like lane departure) actually have a physical warning in the steering system that can be very disconcerting if operators are not expecting it. Your first step might be to actually research what you already have.

No matter what safety or other features your vehicle has, it is still the operator's responsibility to safely navigate the roads. Here are just a few of these features to consider learning:
