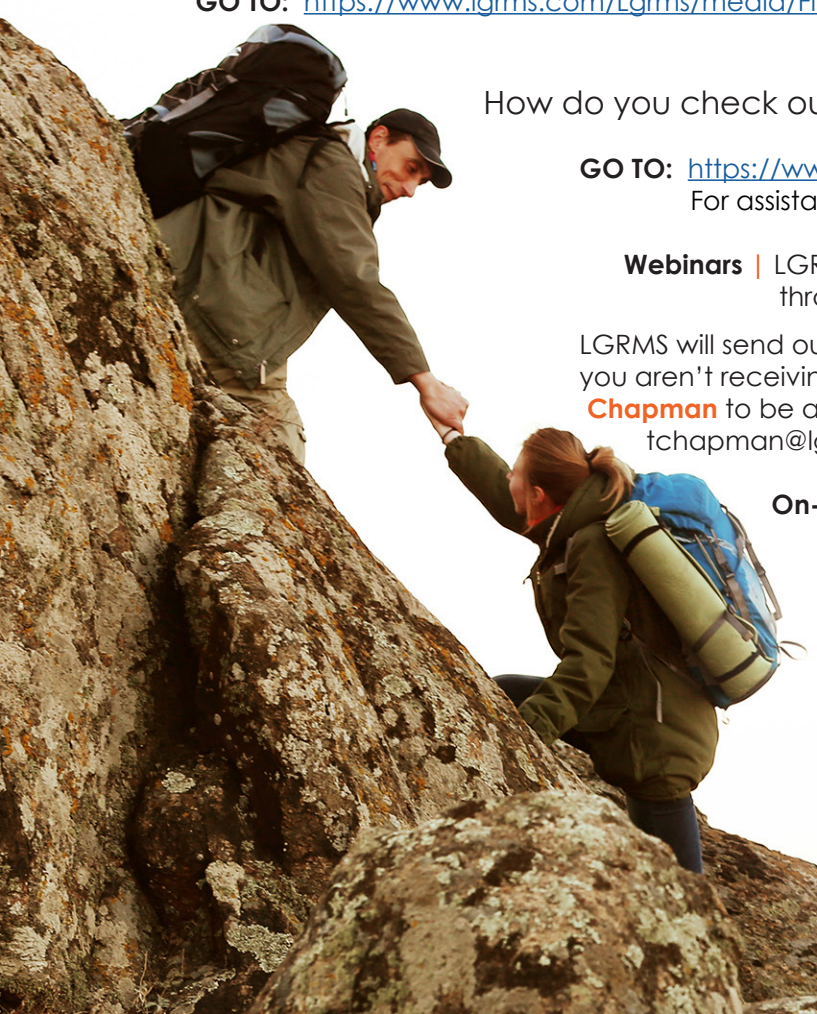

Public Safety Driver Training

LGRMS offers Public Safety Driver Training that is both mobile and state of the art. A combination of classroom instruction and behind the wheel use of a DORON Precision 550 LE driving simulator, this training will give your department up-to-date and realistic training. This training is offered at no cost to the Risk Management members of ACCG and GMA workers compensation and property / liability insurance programs. LGRMS has three simulators installed in trailers positioned around the state so the program can be brought to you.

De-escalation Decision Based Training

LGRMS offers a Law Enforcement Train the Trainer Program for De-escalation and response to resistance at no charge to our member cities and counties who participate in the Property and Liability and Workers' Compensation insurance pools.

Below 100 offers a commonsense approach to officer safety, targeting areas of improvement that are under an officer's control. The training has proved both popular and effective, with many agencies reporting reductions in injuries, crashes and claims, as well as an overall uptick in safety awareness.

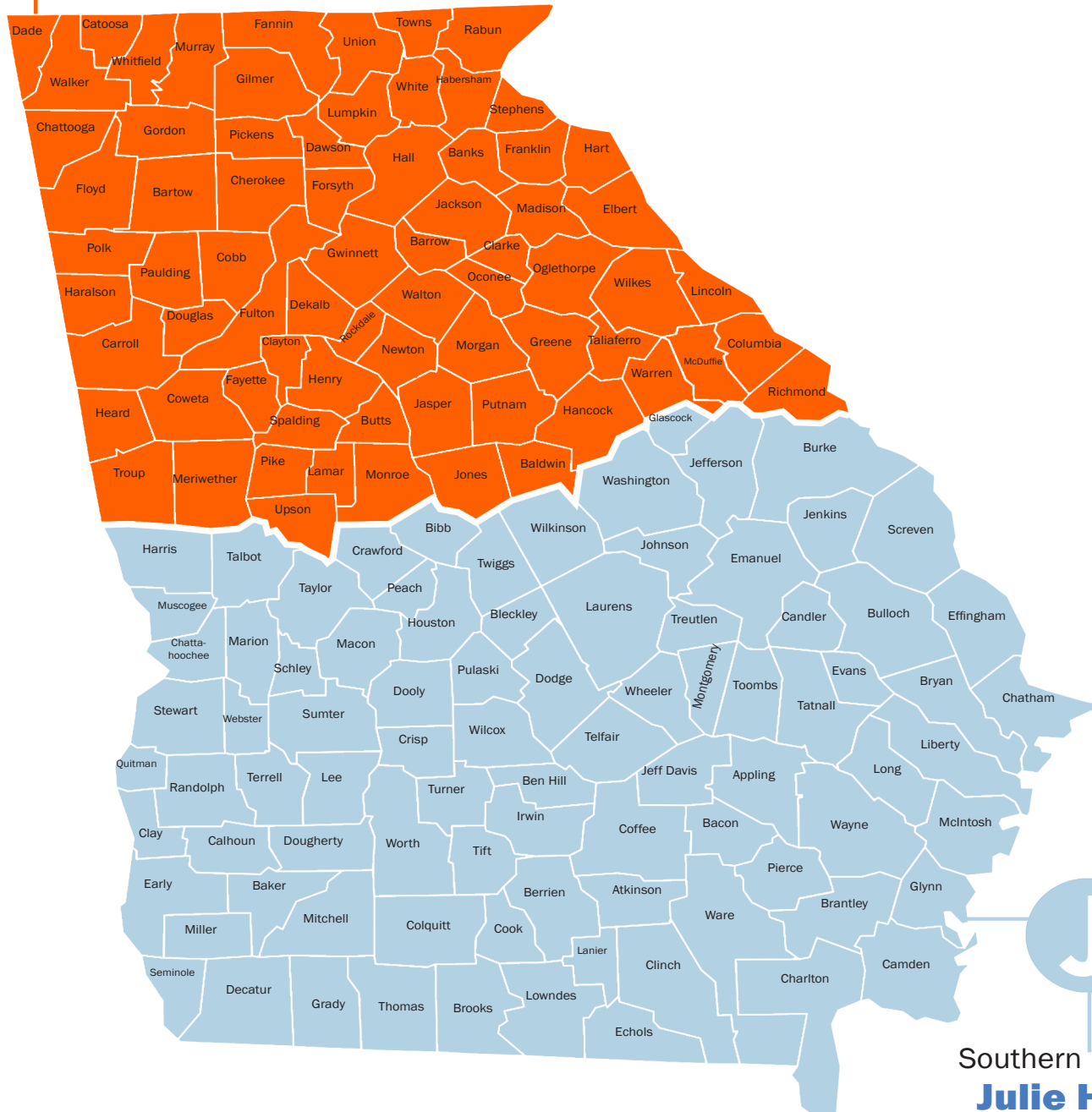

Are we required to comply with Loss Control Recommendations from LGRMS?

After each on-site survey, your Loss Control Field Rep may make recommendations. It is your job to evaluate those recommendations, assess the risk and create an action plan to address them. Our requirement is that you respond back to us within 60 days.
